## BYLAW NUMBER 13C2018

**BEING A BYLAW OF THE CITY OF CALGARY  
FOR A CLOSURE OF A ROAD  
(PORTION OF ROAD EAST OF THE SE1/4  
SECTION 22, TOWNSHIP 22, RANGE 29, WEST  
FOURTH MERIDIAN AND WEST OF THE SW1/4  
SECTION 23, TOWNSHIP 22, RANGE 29, WEST  
FOURTH MERIDIAN THAT LIES SOUTH OF THE  
NORTHERLY 25.20 (TWENTY FIVE AND TWO  
TENTHS) IN PERPENDICULAR WIDTH AND  
NORTH OF THE SOUTHERLY 15.00 METRES  
(FIFTEEN) IN PERPENDICULAR WIDTH)  
(CLOSURE LOC2017-0345/CPC2018-1075)

**WHEREAS** The City of Calgary has decided to close from public use as a public street and to sell or to hold those portions of street described below;

**AND WHEREAS** the provisions of Sections 22 and 606 of the *Municipal Government Act*, R.S.A. 2000, c.M-26 as amended, with respect to notice of intention of Council to pass such a Bylaw have been complied with;

**NOW, THEREFORE, THE COUNCIL OF THE CITY OF CALGARY ENACTS AS FOLLOWS:**

1. Immediately upon passage of this Bylaw, the following described street shall be closed from use as a public highway:

PORTION OF ROAD EAST OF THE SE1/4 SECTION 22, TOWNSHIP 22, RANGE 29, WEST FOURTH MERIDIAN AND WEST OF THE SW1/4 SECTION 23, TOWNSHIP 22, RANGE 29, WEST FOURTH MERIDIAN THAT LIES SOUTH OF THE NORTHERLY 25.20 (TWENTY FIVE AND TWO TENTHS) IN PERPENDICULAR WIDTH AND NORTH OF THE SOUTHERLY 15.00 METRES (FIFTEEN) IN PERPENDICULAR WIDTH

EXCEPTING THEREOUT ALL MINES AND MINERALS

2. The proper officers of The City of Calgary are hereby authorized to execute such instruments as may be necessary to effect the purpose of the Bylaw.
