Re: Plan To Reduce The Tax Weight For Non-Residential Property Owners

On behalf of the Building Owners and Managers Association of Calgary (BOMA Calgary), we would like to thank Council for their attention to this important issue, and for allowing us the opportunity to participate in the stakeholder process. BOMA Calgary represents the commercial real estate ownership and management sector in Calgary and southern Alberta, with members active in all building types. Like residential properties, the non-residential property tax in Alberta is levied against a building, making our industry a primary stakeholder and impacted party in the assessment process. It is through this experience that we believe we can provide relevant insights on ways to improve the results for all Calgarians.

In the Fall, the City of Calgary confirmed that downtown office vacancies account for a \$192M loss in tax revenue, corresponding to a loss of over \$12B in property value. In identifying optimal solutions, we believe it is important to understand that the lost tax revenue will not persist at the current level indefinitely. However, downtown values are unlikely to return to their pre-2015 zenith either. This is why we believe that the City will require finding about half of that lost revenue through other means.

The economic downturn has brought to light the unsustainable nature of our current taxation split within the non-residential tax base, and between residential and non-residential ratepayers. As downtown property values have diminished, additional revenues have to be generated elsewhere. This has resulted in nearly two-thirds of the non-residential tax base seeing double digit tax increases in 2019. While the 2019 budget process saw an \$8M transfer of the burden to the residential tax base, the split at approximately 4:1 remains a significant barrier to competitiveness in our city. As we've seen since 2015, the residential tax base is a more stable source of revenue with less volatile changes in value. For that reason, BOMA Calgary believes that a phased-in shift towards the residential tax base that represents approximately half of the \$192M is essential to a more sustainable revenue model for the City.

In addition to this shift from non-residential to residential properties, we believe that the City of Calgary has additional levers to ameliorate the situation. First, we believe that municipal spending discipline must be maintained to ensure that future budgets and councils are not handcuffed by the need to generate additional revenue from the tax base. Second, we would encourage the city to undertake a

strategic review of non-core, potentially underperforming assets that could provide a return as well as ongoing tax revenue.

In summary, we believe that adjusting the tax ratio to a more sustainable split, in addition to spending discipline and a strategic review of non-core assets would go a long way in ensuring Calgary remains a location of choice to move, start, and grow a business. These businesses, both small and large, are the lifeblood of our economy and our centre city and it is crucial that we act immediately. We would like to thank Council and Administration for their attention to this topic, and look forward to continuing this important work.

I understand that City Council will be considering a motion of Councillors Jeff Davison and Ward Sutherland in respect to the Entertainment and Cultural District vision and specifically two key projects, being the Event Centre and BMO Expansion. I am writing to express my support for both of those two key projects as I believe they are integral to the future of the City of Calgary and its future as a major business center in Canada.

The revitalization of the East Village area and the River District are, I believe, significant and important to the future for the City. Hello Steve (et al):

I appreciate your hard work on this and taking the time to include me in your update below regarding these timely matters before our City Council. I am hoping to attend the Thursday meeting, but may also be unable to as I have a plane to catch that day – hence, I send this email.

I am concerned about all of this below, but as a Calgarian I am MOST concerned about the Event Centre (New Arena).

Like you, I think it is a real possibility the Flames could sell to another party who would be interested in moving them (Houston has long been rumoured, but Oklahoma City and Kansas City have also been mentioned as possible U.S. destinations), in the event the City does not vote to go forward with a new arena proposal on January 28th. In my opinion, we could become "Winnipeg the Re-run" (the version after they lost their beloved Jets). However, the big difference is that we would unlikely have the NHL Governors approve the transfer of another franchise to take the Flames' place, if there is no new arena existing to house them. Anyone who believes otherwise, has simply not been following Gary Bettman over the years. If we chose to then build a new arena a number of years later in order to entice to another team to expand or relocate here, we would have to do so at a greater public cost - most likely 100% (re: without any owners contributing a private share to the build).

For anyone who is interested in discussing the economics of a new arena to Calgary, I invite them to read (or re-read) as the case may be] an Op/Ed article the Calgary Herald published before the last municipal election in October 2017. I attach a photo of the article as it appeared in the newsprint then, as well as the PDF word version, which may be easier to read – same content.

In my respectful view, this article's rationale and reasoning still apply today and have yet to be contradicted. The view of certain economists who claim there is no net economic benefit to building a new arena with public money base their position on **the flawed premise** that citizens have finite entertainment dollars to spend, which they will simply spend elsewhere in our City if the Flames are not an option, for instance on the theatre, movies, or the opera.

challenge that notion in the age of Netflix and with the history of Winnipeg and Quebec City as contradictory examples of a Canadian city losing its team and the related economic benefits (not to mention civic pride!).

There are numerous economic benefits which would justify the infusion of some reasonable amount of REAL public money (re: actual dollars, not "magic beans") to go hand in hand with the Flames' private investment, including:

- concert dollars that otherwise go to Edmonton;
- players' property taxes,
- •associated restaurant and hotel activity of fans as well as visiting teams/performers and their entourages (especially if there is a Red Mile: Go Flames Go!!),
- permanent and tax-paying organizational jobs,
- •the jobs and materials required to construct and then maintain the new arena, and
- •the significant charitable donations of roughly \$4M annually to local charities from the Flames Foundation.

I have taken the liberty of also sending this email to three of our City Councilors: Sean Chu, Joe Magliocca, and Jeromy Farkas, as well as some others in my personal network, in order to share my views as a concerned Calgarian and invite others who care to do the same.

Thanks for letting me piggyback your email with my thoughts on this most important matter for our City's future.

We are concerned that there would be many economic benefits lost if Council does not approve moving forward with these projects. Especially if it meant losing our beloved Calgary Flames to another city, which we believe is a very real possibility.

Approval of the projects makes such such good economic sense considering the benefits that would be realized, some of which are:

- jobs created/\$\$ from materials required for the actual construction phase and for maintenance thereafter
- revenue from concerts that Calgary is now missing out on (often these \$\$ end up in Edmonton)
- associated money spent at restaurants, hotels, and sometimes local attractions by fans, visiting teams and performers and all their crews
- the benefit of having team players and staff, with their families, living in our city considering not only their spending (property taxes, etc.), but the significant charitable donations made locally by The Flames Foundation, as well as the good will and civic pride generated

We respectfully ask City Council to find a way to support the River District development, including financial support as required.

Given our current economic issues, it is more important than ever to have a constructive and strategic vision for the City of Calgary, including development of the River District with a new Event Centre and BMO Expansion.

Dear Mayor Nenshi and Calgary City Council:

Calgary is famous for its entrepreneurial spirit and being home to companies that have shaped Canada's economy while driving the growth and prosperity in this city, and there is a need to safeguard this for the future. The harsh economic landscape is at a critical point for many companies and is a threat to the vibrancy of the business community and the quality of life for all Calgarians. As a city, we must adapt to the new economic reality to ensure Calgary continues to be a leading centre for business and a place of opportunity for all citizens. We must all tighten our belts and prioritize spending, but one action City Council can take to help local businesses would be to address the increases to suburban non-residential property owners as a result of decline in market value in the downtown. We fully support reducing the municipal non-residential to residential tax rate ratio to transfer some of the tax load from non-residential properties to residential properties.

There aren't simple solutions to resolve complex challenges like a structural change in the energy sector or the historic high downtown office vacancies and declining values, but we urge Councillors to consider the following three steps as a start:

- 1. Transfer a portion of the municipal property tax load from non-residential to residential properties over four or five years.
- 2. Continue the current efforts to reduce operational spending by the City.
- 3. Use one-time funding from the City's financial reserves to buffer some of the exceptionally high municipal non-residential tax increases until the transfer of some of the municipal property tax load on non-residential property owners has been achieved.

Taking these actions would help local companies in a transitioning economy while mitigating the impact on hard-hit suburban businesses, Calgary has maintained some of the lowest residential property taxes in Canada. This needs to re-balanced to catalyze business growth.

City Council is aware of the challenges and has responded with lower spending and accessing reserve savings to mitigate the impact on non-residential property owners. More needs to be done to ensure Calgary's competitiveness as a business-friendly city.

These changes would align with *Calgary in the New Economy*, the economic strategy approved by Council last year that highlighted a positive business environment as critical to future prosperity. By addressing the non-residential property tax issue now, Council can continue to build a business-friendly environment, paving the way for businesses to drive Calgary forward and create opportunities for all citizens to prosper. I am writing this letter in response to the conversation going on right now about the Rivers District – and the need for a new Event Centre. I thought it might be helpful to share with you how the Calgary Flames got here in the first place. In 1981 I was retained as a consultant to put together a plan for the official opening of the Olympic Saddledome - then under constructions. There were nine stakeholder organizations – all with a different idea of how it should be done – so it was an interesting challenge. To help me understand the background - Doc Seaman loaned me his file of correspondence with then Premier Peter Lougheed about the future of Calgary. It showed me that in 1980 Premier Lougheed asked Doc and some other prominent businessmen how the Provincial Government could help Calgary improve the quality of life for its citizens and become a world class city. The answer from Doc and friends was that Calgary needed a major event Centre that could attract world-class entertainment. At the same time - another group of citizens had been toiling for years to try and attract the winter Olympics to Calgary and area. In order to be successful – they knew that they would need a major indoor ice rink to host the Olympic events. The Stampede Corral wouldn't do the job. In typical Calgary "can-do" fashion a committee of community and business leaders was formed and they started to work on it. They quickly discovered that in order for a new event Centre to make sense – it would need a major tenant that could provide the revenue needed to keep the lights on - after the Olympics. Premier Lougheed once again called on Doc Seaman to find a solution. Doc suggested that they might look into trying to attract an NHL franchise – did some research – and initiated negotiations with the Atlanta Flames - and - together with some other businessmen - they bought the Flames and moved

Those owners invested their own money to buy the team – with no government support – and continued to invest several million dollars for several years to cover the operating losses before they ever cashed a dividend cheque.

Those same Flames owners invested \$5M through the Flames Foundation to match funds provided by the Rotary Clubs of Calgary to form the Rotary/Flames Gift to the community fund - which provided funds to build Rotary/Flames House – a hospice for terminally ill children – The Urology & Prostrate Institute – Project Nueroarm for robotic brain surgery – and several other medical facilities.

Today we have The Hotchkiss Brain Institute – The Libin Cardiovascular Institute – The McCaig Institute for Bone & Joint Health – Doc's Project Nueroarm - and many other facilities and programs dedicated to improving the quality of life for Calgarians. You'll find the Flames owners are continuing to be behind many positive events in Calgary – including the annual Champions Tour Golf event at Canyon meadows Golf Course that has raised about \$2M for youth programs in the Province.

Without those forward-thinking Flames Owners – Calgary today would be a shadow of what it is – no Saddledome – no 1988 Winter Olympics – No Canada Olympic Park and all of those Olympic facilities – and certainly not the "can-do" city that has attracted businesses – entrepreneurs – and the very high-quality professionals - workers – and families that make this City truly "world-class!

Today the Flames are telling us that in order for them to remain competitive and continue to bring world-class entertainment to the city – they are going to require a new facility with all the features – and bells and whistles that all the other teams have. Surely, we can find the leadership – courage and vision among our civic leaders – to come together with the Flames to find a solution that works for everyone?
