# **Business Advisory Committee Terms of Reference**

#### **EXECUTIVE SUMMARY**

At the 2018 October 15 Combined Meeting of Council the Notice of Motion C2018-1219 was passed to establish a Business Advisory Committee (BAC).

The purpose of the committee is to be the conduit to address perceived City of Calgary barriers that business stakeholders face in their everyday operations.

This report summarizes the Terms of Reference and establishes the mandate of the Business Advisory Committee.

# **ADMINISTRATION RECOMMENDATION:**

Administration recommends that Council:

1. Adopt the Business Advisory Committee Terms of Reference (Attachment 1).

#### PREVIOUS COUNCIL DIRECTION / POLICY

On 2018 November 19, Council directed through the Notice of Motion C2018-1351 that "Council defer the due date of a proposed Terms of Reference from 2018 December to Q1 2019".

On 2018 October 15, Council directed through the Notice of Motion C2018-1219 that "Council support the creation of the Business Advisory Committee"; that "Council nominate two (2) Councillors to serve as members of the Business Advisory Committee (one Councillor to serve as Chair) during the October 22nd Organizational Meeting of Council"; that "the Business Advisory Committee report back to Priority and Finance Committee semi-annually"; and that "the Business Advisory Committee bring back a proposed terms of reference no later than December 2018."

#### **BACKGROUND**

Since 2019 October, Calgary Approvals Coordination through its Partnership Services division has been working with the Ward 1 Office and The City Clerk's Office on the development of a Business Advisory Committee Terms of Reference (Attachment 1). The Terms of Reference aligns with the Council policy on Governance and Appointments of Boards, Commissions and Committees (CP2016-03) and includes a mandate, committee composition and term lengths and limits of members.

#### **INVESTIGATION: ALTERNATIVES AND ANALYSIS**

The Business Advisory Committee Terms of Reference supports the establishment of a Council committee to address perceived City of Calgary barriers that business stakeholders face in their everyday operations. Additionally, the Terms of Reference also outlines responsibilities of a working group, whose membership will include many members from external organizations and multiple City departments, which will work with the BAC to ensure the committee can achieve its mandate. The responsibilities of the working group are to identify current challenges or obstacles and recommend where the City of Calgary can improve its practices to ensure

The BAC and the working group will communicate the ongoing work of the committee, along with any related improvements through various channels for wider industry awareness and publicly reinforce Calgary's business-friendly reputation.
