

Foothills Athletic Park Redevelopment Assessment Committée Terms of Reference

EXECUTIVE SUMMARY

At the 2019 January 28 Strategic Meeting of Council the Foothills Athletic Park Redevelopment Assessment Committee (FAPRAC) was established.

This report summarizes the Terms of Reference and establishes the start time and date of the first meeting.

PREVIOUS COUNCIL DIRECTION / POLICY

Council at it's 2019 February 04 Combined Meeting adopted the following:

"That with respect to Verbal Report C2019-0162, the following be adopted: That Council:

- Appoint the following Councillors to the Foothills Athletic Park Redevelopment Assessment Committee:
 - 1. Councillor Colley-Urguhart; and
 - 2. Councillor Carra.
- 2. Direct that the Committee return to Council with a Terms of Reference no later that 2019 March.

At the 2019 January 28 Strategic Meeting of Council the Foothills Athletic Park Redevelopment Assessment Committee (FAPRAC) was established.

BACKGROUND

The Council policy on governance and Appointments of Boards, Commissions and Committees (BCC), ("CP2016-03") states the following:

"Upon the establishment of a new City BCC, Council shall approve the City BCC's Governance Document(s) that includes:

a) Mandate;

b) Composition;

c) Term lengths and limits of Members..."

In addition, CP2016-03 provides that "[a] new BCC's Governance Document(s) must be adopted by Council before any Member is recruited and appointed to the City BCC."

INVESTIGATION: ALTERNATIVES AND ANALYSIS

Term Length

Initial appointment and term of Councillors to FAPRAC is made by Council resolution. Starting at the 2020 Organizational Meeting, Councillors are appointed to FAPRAC for one-year terms expiring annually at the Organizational Meeting.
