I would appreciate it if you could add this to the file on the address 6404 18a st. s.e. Calgary. I am writing this letter on behalf of the many residents of the community of Millican Estates in S.E. Calgary. We have a signed petition with over 1100 residents signatures (these were just the ones we were able to talk to) . The majority of the residents we talked to were strongly against rezoning this lot. Jim Logan (owner/developer) says he lives in this community and he cares about the residents here but the number of signatures on the petition do not lie about what our community wants

There is about one hundred or more years of history in this great community and while some of the properties need upgrading or development we are totally against having our streets ultimately lined with apartments, row housing and multi family structures.

Many of these homes were built by the employees of C.P.R., Calgary Packers, Burns Meats and Calgary Stock yards. Many residents built garages first where they lived while building their homes. I watched my grandfather build four homes this way. My father and uncle also built hames this way. Much of the materials used in these homes were leftover scraps from projects at the C.P.R. yards. It would be such a crime to see these historic homes taken down in order to line developers pockets.

Many of the homes in our community now have basement suites and that itself indicates this area has grown immensely over the past decades. This also means the traffic and parking concerns have also increased. We feel that demolishing a single family home and replacing it with a large multifamily structure in the same parcel of land is not a good idea and will only add to the problems and concerns we already cope with. A four plex with four suites in the basement leaves little or no room for any type of individual storage facilities (sheds, mowers, bikes, toys and tires. Putting these types of homes in this area would also be a strain on the present water, sewage and electrical systems.

A large multi structure means 24 more garbage, compost and recycle bins. That is only for one structure. Also more vehicles and more traffic in an already stressed road system

The landlords of rentals also seem to be delinquent and blind to what goes on in their rental properties.

Renters tend to have a lack of vested interest in the care taking of the property as they will move on some day. That leads us to believe that these landlords are in it for financial gain and not for the good of the community. The more rentals we have in this community the more our property values go down. Calling 311 does not seem to help in these matters. Our concerns and complaints seem to be communicated to a deaf ear.

There have been many young families purchasing homes in this area over the past few years because it is not only affordable but they like what this area has to offer. We have large yards, plenty of mature trees, lots of parks and green space, schools, shops and places of worship. We are now considered inner city and that is what draw these families to our nice quiet area for the long run. A great place to bring kids up away fro the hustle and bustle of other very busy communities.

We have attended the last few community meetings to voice our concerns. Jim Logan (owner/developer) of the application address and our Council person (Mr. Carra) were at one of those meetings and despite our concerns Mr. Carra said he was a big fan of multi family dwellings. We the residents voted Mr Carra in and we do not want this and it is his job to be an advocate for us. Seems like he could care less about his constituents in this area who have worked so hard to keep the legacy of those who built this great community into what it is today.

We as a community encourage new development R-C2 or renovations to existing homes or duplexes.. Like any other community in Calgary there are residents that could careless what their properties look like but the majority do care.

The ones that care are the ones that speak out and want to be heard...

The community in this location was designed with an R-C2 guideline. Along with the concerns noted below, are concerns for density, concerns of traffic, parking, and height concerns, and also precedence that this redesignation of land will lead to many more...with further impacts.

How does the existing infrastructure in the community handle the additional water/sewer services without further impact without upgrades required and significant tax impacts to pay for upgrades. (I ask this because I even think of all the condo conversions in recent years and then units adding just a washer and dryer to their unit. Over time the condos faced water main breaks continually because there was never the infrastructure in place to handle the enhanced capacities and services.) Water services have been upgraded in recent years but the current land-use in the area is for an R-C2 guideline. How can services handle a denser land-use in the area? One lot may in fact, but the precedence for additional redevelopment may cause issue in the long run. The City upgraded underground services in recent years. Why would the lines be increased to handle multi-family applications in a current R-C2 zone?

With LRT coming and a current council that is promoting the opportunities to increase tax revenues in existing communities, it is important for our community to be cautious of development plans that threaten or completely change the way "owners" feel confident to live and raise their families. We have a family style neighbourhood that people have purchased homes given the land-use in place. In addition, if multi-family housing moves into areas designated R-C2 and R-C1 the new owners will be more often landlords and tenants do not historically "care" about neighbourhoods the way "owners" do. This is mostly because they lack a vested interest as owners have. As an example, this is why CMHC will only insure complexes with a favourable owner percentage.

We already have a diverse balance of homes in Ogden. We need to be cognizant of the balance, as more people are moving here and renovating homes, also helping to improve the range of demographics and also encourage higher household income families to the neighbourhood also. That is important in the community balance also in order to be sustainable, strong, and vibrant. We have a high percentage of rental property and affordable property already. According to the "2014 Community Profiles" data through Calgary.ca, our community consists of 58% single family dwellings, which is 9% lower than Calgary as a whole.

How can the Administration be generally in support of the proposed redesignation” to R-CG?  
R-CG is a manipulative “new land-use” for the City to be able to inch their way into existing communities with a lower density residential land-use, but allow multi-family development within this guideline. It was developed to help increase tax revenue in existing communities, that can’t do it without a change of land-use. It could be a potentially threatening way for the City to get their revenues at the expense of community dynamic and balance.

It is up to the residents of our community to hold onto our family designated community.  
When the strategic planning was put in place years ago along 62 Avenue, the City planning office zoned primarily R-2, not R-M4. There was a strategic plan for a FAMILY COMMUNITY. How is it legal for “Administration” to just put Land-use changes into their “new” strategic planning, make friends with developers who will make applications, and therefore help the City get their revenue stream increased?

THERE ARE NOW NEARLY 1200 NAMES IN A PETITION by people living in Millican, Lynnwood, Ogden (Greater Ogden) against this re-designation because we know it will set a precedence for every other lot on 62 Avenue and beyond. It is harmful and not helpful to our betterment and enjoyment on 18A Street with Century homes, treed lots, and families within blocks of schools and playgrounds.

What is the purpose of a public hearing if the people’s concerns are ignored? How do we community owners protect our community going forward between now and these coming years of developers changing our landscape and therefore our community culture? I wrote a very similar email to my Alderman’s office in Ward 9 on February 27, 2019 and no one responded to my email in the alderman’s office. Please listen to our concerns so that we can identify and know we are actually respected and listened to, maybe even truly cared about.

We are already witnessing this lack of concern or care through the many public meetings whether for LRT, tunnels on 78th Ave, or the ARP between 25 Street and Ogden Road. We will be in attendance at the Public Hearing for this Land Use Redesignation on April 29<sup>th</sup>, 2019.
