Resignations - Public Art Board and Social Wellbeing Advisory Committee

EXECUTIVE SUMMARY

Administration received notification of two resignations:

- Robert Reid, serving on the Public Art Board as a Citizen-at-Large; and
- Karla Danan, serving on the Social Wellbeing Advisory Committee as a public member who has knowledge of the needs of and connections to networks of a diverse population.

This report recommends that the positions remain vacant until the 2019 Organizational Meeting of Council.

- 2. Thank Karla Danan for her service on the Social Wellbeing Advisory Committee; and
- 3. Direct that the positions remain vacant until the 2019 Organizational Meeting of Council.

PREVIOUS COUNCIL DIRECTION / POLICY

On 2018 February 26, Council appointed Robert Reid to the Public Art Board as a Citizen-at-Large member, for completion of a three-year term expiring at the 2020 Organizational Meeting of Council.

On 2018 October 22, Council appointed Karla Danan to the Social Wellbeing Advisory Committee as a public member who has knowledge of the needs of and connections to networks of a diverse population, for a term expiring at the 2019 Organizational Meeting of Council.

BACKGROUND

Public Art Board

"The Public Art Board, an advisory committee to Council, is responsible, in consultation with Calgary Art Development Authority (CADA), to advocate for public art, advise on public art policies, procedures, guidelines, plans and issues as they relate to The City of Calgary, and provide support to Administrative staff and programs. The Public Art Board operates at arm's length and reports its activities, developments and recommendations in an Annual Report to Council." (*Corporate Public Art Policy*, CSPS014). The Public Art Board's composition and quorum are detailed in Attachment 1.

Social Wellbeing Advisory Committee

The Social Wellbeing Advisory Committee works with Administration to advise Council on Council and Administrative policies, strategies and service delivery in accordance with the Social Wellbeing Principles.

The Social Wellbeing Advisory Committee's main purpose is to provide advice using an intersectional approach (meaning to consider how decisions impact people who are members of multiple, overlapping population groups) by drawing on different perspectives of its membership.

INVESTIGATION: ALTERNATIVES AND ANALYSIS

On 2019 May 1, the Chair of the Public Art Board informed Administration of Robert Reid's resignation, effective immediately. Due to restructuring, the Board recommended that the position remain vacant until the 2019 Organizational Meeting of Council. Following the resignation, there will be ten members remaining on the Public Art Board, allowing quorum to still be attained.

On 2019 May 27, Administration received notice of Karla Danan's resignation, effective immediately. The Board recommended that the position remain vacant until the 2019 Organizational Meeting of Council. Following the resignation, there will be twelve members remaining on the Social Wellbeing Advisory Committee, allowing quorum to still be attained.

Stakeholder Engagement, Research and Communication

Administration consulted with the Chair of the Public Art Board, who confirmed that the position should remain vacant until the 2019 Organizational Meeting of Council, at which time Council will make regular appointments to the Public Art Board.

The resource for the Social Wellbeing Advisory Committee confirmed that the position should remain vacant until the 2019 Organizational Meeting of Council, at which time Council will make regular appointments to the Social Wellbeing Advisory Committee.
